

Acquisition of Land from Orange County, Virginia Records:

- Pages 248-51. 24-25 Sept. 1741. William Beverley, Esq., of Essex County to Arthur Hambleton of Orange County. Lease and release; for £16 current money. 515 acres on the west side the blue ridge of mountains, part of Beverley Mannor... corner to William Ledgerwood... James Leper's line... corner of Capt. James Patton... (signed) W. Beverley. Wit: Francis Beaty, Joseph Reed, John Bohannan. 25 Sept. 1741. Acknowledged by William Beverley, Esq. [Orange County Virginia Deed Book 6, Dorman, pg. 32].

Acquisition of Land from Chalkley's:

- Page 424.--28th February, 1749. William Beverley to Arthur Hamilton. 270 acres in Beverley Manor. Corner Nathaniel Davis. Corner James Gilmer's line; James Woody's land. Corner James Leeper. Corner said Hamilton's old plantation.

Disposition of Land from *Chalkley*'s:

- Page 239.--20th May, 1752. Arthur Hammilton and Barbara to James Moffett, 200 acres. In Beverley Manor; corner Wm. Ledgerwood; Col. Patton's, alias James Kerr's, line. Teste: Robt. Cunningham, David Hay.

From *Chalkley*'s:

- Page 65. (?), 1797. Arthur Hamilton's will--To wife, Barbara; daughters, Margaret, Mary, Sarah; sons, John and James; daughter, Martha; sons, David and Alexander. Executors, wife Barbara and son John. Teste: Wm. Blair, Patrick Hays, John Cunningham. Proved, 23d June, 1906 (*s/b 1806*). John qualifies.

Processioning Lists of 1747/48, 1755 & 1759

"Processioning" was the periodic review and agreement of property lines between settler's lands. Processioning Lists are useful in determining the general area of a settlers lands and their neighbors at specific time periods:

Henderson; processioned for John, Robert, William Christian; 10th March, processioned for Thos. Stewart, present James and John Black. 8th March, 1747-8, Edward Hall's land not processioned, there being a dispute between the said Hall and Col. Patton, not at home.

- Page 458.--27th February, 1749. Same (From William Beverley) to William Currey, 360 acres Beverley Manor. Corner tract first surveyed for James Bell, now in possession of Andrew Cowin. Corner William Nutt. Tract surveyed for Adam Thompson, now belonging to Robert McClenachan. Corner Samuel McCorkall's land. Corner to James Moody; Cowin's line. Teste: **Arthur Hamilton**, John Linn, George Anderson.
- Page 429.--(prob. 27th Februart, 1749) William Beverley to William King, farmer, 251 acres in Beverley Manor. Corner John Trimble. Corner Morrice O'Friel. Teste: David Cunningham, James Alexander, **Arthur Hamilton**.
- Page 532.--28th February, 1749. Same (From William Beverley) to James Rosebrough, 240 acres in Beverley Manor. Patent line of Beverley Manor. Teste: **Arthur Hamilton**, William Campbell.

- Page 635.--28th February, 1749. Same (From William Beverley) to Nathaniel Davise, 150 acres in Beverley Manor. Corner **Arthur Hamilton**; corner Samuel Downey and James Gilmore. Teste: George Pirie, James Henderson.
- Page 173.--(abt. 28 November, 1751) John Lynn, Jr., and Jean, to Nathan Gilliland, 383-1/2 acres. In Beverley Manor; John Bigham's line; corner Jno. Buchanan; Jno. Hendersons line; John Lynn, Sr.'s, land. Teste: **Arthur Hamilton**, Samuel Wallace.
- Page 223.--20th May, 1752. Patrick Campbell, Sr., and Elizabeth, to Patrick Campbell, Jr., 212 acres. From Beverley to Patrick, Sr., 21st February, 1738; Wm. Thompson's line; Samuel Braford's and John Mitchel's lines; corner John Ward; corner Charles Campbell. Crossing Christian's Creek and South River. Teste: David Hay, **Arthur Hamilton**.
- Page 268.--20th May, 1752. Alexander Campbell, farmer, to William Campbell, 200 acres. In Beverley Manor, at his father's and Wm. Ledgerwood's corner; his father's and his brother David's corner; his brother Robert's corner; James Moffet's line. Teste: **Arthur Hamilton**, Samuel Henderson.
- Page 516.--15th August, 1753. John Brownlee's bond as guardian (appointed) to Alexander McNutt, orphan of James McNutt, with sureties Samuel Doake and **Arthur Hamilton**.
- Page 141.--4th August, 1755. John Glass's appraisal by James Caldwell, Andrew Alexander, John Shields. John Glass's estate due to Patrick Kenan, Thomas Shields, Robert Moody, Wm. Long, Jas. Moody, Jno. Bigam. Samuel Downy, Thos. Brown, Jas. McLong, **Arthur Hamilton**, Wm. Karr.
- Page 334.--25th June, 1757. James Moffett's will, farmer--Sons, John and James Moffett, the plantation to be divided between them by a line beginning at middle of Wm. Ledgerwood's pasture, cross the Hasle Bottom, thence to James Carr's land; to daughter, Elizabeth; daughter, Mary; son-in-law, John Berryhill, and his wife, Rachel Berryhill; son James is infant; daughters, Martha and Elizabeth; daughter, Jane; to son-in-law Wm. Campbell and his wife Margrett; to Ann Miller, 1 dollar. Executors, Wm. Ledgerwood and James Mitchell. To son-in-law James Berryhill. Teste: Wm. Edmiston, **Arthur Hamilton**, Robt. Alexander. Proved, 26th March, 1764, by Edmiston and Hamilton. Executors refuse to execute and James Moffett is granted administration, who qualifies with **Arthur Hamilton** and Walter Smiley.

- Page 361.--6th December, 1759. Jno. Gay's will--To son Henry Gay (infant), part of 347 acres promised to John by his (testator's) father, Henry Gay; to wife, Mary Gay; to father. Henry Gay, all wearing apparel; to be educated in reading and writing (this must refer to son Henry). Executor, father Henry. Teste: **Arthur Hamilton**, Fras. McDonald, Nathanl. Davis. Proved, 20th May, 1760, by the witnesses. Executor qualified (his "H" mark), with Francis McDonald, James Lockhart.
- Page 261.--(prob. abt. March, 1760) Nathaniel Davise and Sarah to Francis McDonnall, &#pound;34, 150 acres in Beverley Manor; corner **Arthur Hamilton**; corner Samuel Downey; corner James Gilmer. Teste: Andrew Cowan, **Arthur Hamilton**.
- Page 12.--__ October, 1760. John Guy's estate settlement (the name is Gay in the order), by Henry Gay, administrator--Sold to Francis Donnally, Martha Guy, Henry Guy, Arthur Greer. widow Savers, Wm. Bunting, Agnes Guy, Jean Moffet, Mary Guy, James Borling, Thos. Brown, Timothy Sullivan. Sundries to Elizabeth Gay, Ann Gay. Paid to John Vance, Nathaniel Lyon, John Neall, John Jamison, James McCoy, **Arthur Hamilton**, Maj. Brown, Commadore Brown.
- Vol. 1 - MAY, 1762 (B). - Crow vs. Hoops.--Carlisle, ye 19th January, 1761. Received from Mr. Adam Hoops the sum of four hundred and seventy-two pounds, eighteen shillings and four pence, Pennsylvania currency, in full for 82 head of beef cattle, purchased by **Mr. Arthur Hamilton** and John Metcalf for the use of his Majesty's troops under the command of the honorable Brigadier General Monckton. (Signed) William Crow.
- Page 359.--12th May, 1768. Samuel McCutchan, Sr., and Frances () to Samuel McCutchon, Jr., son of said Samuel 5 shillings, and diverse and good causes done to me; tract Samuel, Sr., now lives on, 150 acres; corner Borden's patent line; William Sprout's line; also all properties. Teste: Robert Patterson, Chas. Campbell, **Arter Hamilton**. Delivered: Jno. McCutcheon, March Court, 1774.
- Page 496.--13th November, 1779. James Gilmore's (Gillmer) will--To wife, Ann; to son, John; to son. James; to son, Alexander; to four daughters, Elizabeth Campbell, Martha Curry, Rebekah Brawford, Janet Peery. Executors, wife Ann and sons John and James. Teste: Elijah McClenachan, **Arthur Hamilton**, Wm. Blair. Proved, 20th September, 1785, by Hamilton and Blair. John qualifies.

- Vol. 2 - 1801--Marriage Bonds in Augusta County - December 24, Wm. Britten and John Hamilton, surety. Wm. Britten and Mary Hamilton, daughter of Arthur Hamilton, and of age.
