<u>Couli</u> (Coule) - Jacob received a warrant for 50 acres in Springfield Township on Mar. 14, 1755.

<u>Dagen</u> - John received a warrant for 125 acres in Springfield Township on Oct. 30, 1772, that was surveyed as 132.47 acres called *Little Value* on Nov. 12, 1772. His will was written in Shrewsbury Township on Jan. 29, 1777, and probated on Feb. 16, 1791 (executed by Elizabet Dagen and Peter Brillhart, and witnessed by Jacob Brillhart and Rudy Yund). He m. Diehl - Johan Adam, son of Hans Georg and Anna Catharina (Hertz), Diehl was b. on Sept. 12, 1690, was confirmed at Herran-Sultzbach in 1704, and d. in York Co., PA, in Apr. 1755. He m. Maria Catharina, dau. of Johan Daniel and Anna Catharina (Esch) Kreischer, of Homberg on Dec. 4, 1712. She was bapt. on Oct. 28, 1696, and d. before 1767. Johann Daniel, son of Georg Kreisher of Mertzweiler, Gerichtsschoffe and Kirchencensor, m. Anna Catharina, dau. of Abraham Esch of Deimberg, at Deimberg on Nov. 18, 1687. They immigrated to America on the ship Samuel on Aug. 27, 1739, and settled in York Co., PA. Adam's will was written on Mar. 31, 1755, and probated on Apr. 16, 1755. They had the following children at Homberg, Germany:

Johann Daniel, b. in 1713. He m. Maria Elisabeth, dau. of Johan Nickel Simon (see entry), in Lancaster Co., Warwick Township, PA, on Dec. 26, 1740. He was b. near Homberg, Landkreis of Kusel, Pfaltz in 1713. He immigrated to PA, on the ship Samuel on Aug. 27, 1739. In 1751, Daniel received a land warrant in Codorus Township near Seven Valleys, and built a mill within a year. He d. intestate in Dec. 1761, and is bur. at Friedensaal Lutheran Church. At the time of his death he owned over 500 acres and four mills. He was naturalized on Apr. 10/11, 1761. Daniel and Maria bapt. the following children at Christ's Lutheran Church of York:

- Johan Carl, b. on Oct. 19, 1742, and bapt. at Christ's Lutheran Church on Nov. 24, 1742. He d. in Adams Co., Cumberland

Township, PA, on Aug. 20, 1820. He m. Christina Catharina, dan of Georg and Catharina (Rausher) Liebenstein (see entry in Manchester section), in Christ's Lutheran Church of York on Oct. 11, 1763. She was b. in Manchester Township on Aug. 5. 1746, and d. in Adams Co. on May 5, 1809. He inherited all of hi father's mill property, and between 1768 and 1783, he built a brick addition to the original stone home. In 1783, he had 2 houses, 1 outhouse, 250 acres, 2 negroes, 4 horses, 8 horned cattle, 10 sheep, 1 grist mill, 1 saw mill, 1 hemp mill, and 2 stills In addition to being a miller, he was a blacksmith. In 1773, he purchased, Groundhog Hill, in Shrewsbury Township, which he later sold part to Andrew Swartz. About 1787, he sold the mill property to Jacob Sitler, moved to Baltimore, MD, and purchased several town lots. In 1792, he sold the remainder of, Groundhog Hill, to Jacob Bowman. About 1805, he moved to Adams Co., PA, and purchased over 775 acres in Columbiana Co., OH, with intentions of moving there. His will was written or Mar. 15, 1812, and probated in 1851.

Anna Maria, b. on Feb. 11, 1744, and bapt. at Christ's Lutheran on Mar. 17, 1744. She d. in York Co., York Township, on Jan. 10 1800. She m. Frederick, son of Killian and Christina Fissel (see entry), and Captain John McDonald, probably son of John and Jane McDonald.

Johan Adam, b. on Dec. 16, 1746, bapt. at Christ's Lutheran on

Feb. 24, 1747, and d. in Aug. 1764.

Georg, b. on Feb. 24, 1750. He d. in Codorus Township on July 28, 1804. He m. Anna Eva, dau. of Georg and Catharina (Rausher) Liebenstein (see entry in Manchester section), about 1774. She was b. in Manchester Township on Apr. 7, 1753, and d. on Oct. 19, 1835. Georg received his father's farm land. He was a tax assessor in 1781, and in 1783 had 300 acres. He was a Private in the 2nd Class of Captain George Geisselman's Company. When he d., he owned 484 acres.

- Maria Elisabeth, b. on Apr. 4, 1715, and m. Johan Adam Simon

Carl Adam, b. in 1717. He m. Maria Elisabeth, dau. of Johan Peter and Anna Margarethe (Becker) Ehrhardt, in Codorus Township on Nov. 24, 1742. She was bapt, at Staudernheim in the Palatinate on Nov. 30, 1716, and d. in Shrewsbury Township about 1795. On Mar. 1, 1755 (issued Apr. 10, 1749 and Oct. 18, 1753) he received a land warrant in Shrewsbury Township called Diehl's Folly. He applied for naturalization on Sept. 24, 1755, and was naturalized on Sept. 24, 1763. On Oct. 3, 1763, he purchased 118 acres and 40 perches (surveyed on Nov. 22, 1766) called Diehl's Chance. On Dec. 22, 1764, he had 394.5 acres called Shrewsbury Town, 344

acres 50 perches on a branch of Codorus Creek, and 249 acres on Deer Creek surveyed. On Apr. 4, 1769, he purchased a grist and saw mill on Deer Creek, which he sold to his bro. Peter in 1771. Carl also had a mill in Shrewsbury Township. He d. in Shrewsbury Township on Apr. 18, 1800. Carl and Maria Elisabeth had the

following children:

Adam, b. on Aug. 12, 1743, and bapt. at Christ's Lutheran Church on Sept. 18, 1743. He m. Anna Elizabeth Seyler, and d. in York Co., Windsor Township on Oct. 30, 1820. She d. in Chanceford Township on Mar. 7, 1831. Adam served under Captain Aquilla Wiley and John Ehrman in the Revolutionary War. In 1783, he was in Shrewsbury Township operating his father's mill on an 115 acre tract. On May 2, 1786, he purchased 71 acres 115 perches in Windsor Township. By 1795, he had a mill and 200 acres. The mill was located on Muddy Creek, and sold by Adam's execs. to his nephew Charles in 1823. Adam is bur. in Lebanon Lutheran cemetery.

Eva Christina, b. in 1744. She m. Frederick Schinleber and Martin, son of Christopher and Philipena Kurtz. Frederick immigrated to America on the ship Richmond on Oct. 5, 1763, and d. about 1777. He took over Charles Diehl's mill on Deer Creek, and later Martin Kurtz took it over. Martin was b. in 1745, and d. in 1836. He was a teamster in the Revolutionary War, and one of the founders of Saddler's Church. Eva Christina

d. in Shrewsbury Township on Aug. 22, 1828.

Elizabeth, b. about 1746. She m. Jacob, son of Jacob and Catharina Scharer (see entry), and d. in Stark Co., Osnaburg Township, Mapleton, OH, in 1825. He was b. on Jan. 9, 1744, and d. in Stark Co. on Jan. 29, 1823. Jacob worked a mill he received from his father in Shrewsbury Township, until about 1805, when he moved to OH. Jacob was a Private in Captain George Long's 6th Battalion, during the Revolutionary War. Johan Carl, b. on Oct. 14, 1750. He m. Christina, dau. of

Christian and Anna Stabler (see entry), about 1777. He d. in Shrewsbury Township on Aug. 1, 1817, and she d. there on 18, 1811. In 1785, he received 356.11 acres from his father, and took over the family farm. He was overseer for Shrewsbury Township in 1780, and tax collector in 1783. Carl served in the York County Militia in the Revolutionary War under Captain Henry Ferree as a Private, 6th Class, and later in Captain John

Ehrman's Company.

Anna Catharina Elisabetha, b. on Dec. 3, 1752, and bapt. at Christ's Lutheran on Dec. 25, 1752. She m. Dewalt/Theobald, son of Jacob and Catherine Scharer (see entry). They resided on the border between Shrewsbury and Hopewell Township.

Angelica Elizabeth, b. about 1721. She m. Johan Valentine, son of Johannes Verdriess, about Aug. 1742. He was b. in Fussengonheim in the Palatinate, and was residing in Frederick Co., MD, in 1779. Angelica was alive in 1772. Valentine received a land grant in Frederick Co., Monocacy, MD, in 1743, and settled on Little Hunting Creek. He was naturalized in MD in Oct. 1743. They had the following children:

 Maria Catrina, b. on May 6, 1743, and bapt. at Monocacy Lutheran Church.

 Johannes, b. on Mar. 11, 1744, bapt. at Monocacy, and was residing in Greenbriar Co., VA, in 1790. He m. Maria Catharina, dau. of Jacob Zither, in Frederick, MD, in 1772.

- Maria Magdalena, b. in Jan. 1747, bapt. at Monocacy, and appears as a sponsor to a baptism of a child of Peter Diehl in Lancaster Co., PA, in 1767.

- Valentine, b. about 1750.

Nicholas, b. about 1724. He m. Maria Catherina, dau. of Johan Nicholas and Anna Barbara (Burkhart) Hantz, and d. in York Township in May 1790. She was b. in Sponheim, Germany, on Feb. 3, 1734, and d. in York in Oct. 1817. Nicholas worked for his father in the milling business, and received 230 acres and instructions to continue operating the mill with his bro. Peter, when his father d. On Oct. 8, 1767, he received a warrant in York Township, adjoining the land he received from his father in all consisting of 260 acres and 27 perches which he named Diehlsburg. He was overseer of the poor in 1757, tax assessor for York Township in 1769, and was Vestryman at Christ's Lutheran Church of York. In 1783, he had 245 acres, one horse and 2 horned cattle. Nicholas and Maria Catharina had the following son:

Peter, b. on Feb. 23, 1760, bapt. at Christ's Lutheran Church of

York on Mar. 2, 1760, and d. young.

Peter, b. about 1728. He m. Anna Maria Margaretha, dau. of Johan Nicholas and Anna Barbara (Burkhart) Hantz. She was b. in Sponheim on Sept. 5, 1737, and d. before Jan. 1801. Peter d. in York Township in Dec. 1812. When his father d., Peter received 130 acres and the mill property. On June 18, 1765, Peter had 160 acres and 94 perches surveyed. Peter and his bro., Nicholas, ran their father's farm and mill until 1762, when Peter sold the mill property to Casper Weaver who sold it the same day to Mathias Sitler. On Sept. 14, 1762, Peter purchased 96.5 acres in Lancaster Co., Donegal Township, and remained there until Feb. 5, 1771, when he purchased a mill property and 248 acres in Shrewsbury Township from his bro., Carl. He also purchased 72 acres and 90

perches in Hopewell Township. Peter and Maria Margaretha had the following children:

Johan Peter, b. on Aug. 8, 1761, m. Susanna, dau. of George Krantz, and Catherine, dau. of Casper Diller on June 18, 1809. Susanna was b. on Aug. 14, 1769, and d. on Aug. 9, 1806. Peter served in the Revolutionary War as a Private in the 5th Class, Captain Frey's Company from 1777-1780. He served in Captain Peter Ford's Company from 1782 to 1783. He worked with his father in the mill business and 1801, he purchased a tract on the Little Conewaygo at the Ox Head Inn. He d. in Adams Co. on Aug. 1, 1839.

Nicholas, b. on Feb. 4, 1765, bapt. at the First Reformed Congregation of Lancaster on Feb. 28, 1765, and spon. by Nicholas and Maria Catharina Diehl. He m. Elizabeth, dau. of George and Anna Maria (Holtsinger) Bentz, and d. in York Township on Oct. 11, 1847. She was b. in 1767, and d. on Jan. 14, 1818. He was a Private in Captain Godfrey's Company in the Revolutionary War from 1777 to 1780. He was a farmer in York Township, and later purchased lots in Freytown with his bro., Jacob. He was Director of the Poor for York Township from 1831 to 1834.

- Johan Adam, b. on Feb. 26, 1767, bapt. at Maytown Lutheran Church on Apr. 17, 1767, spon. by Andreas Arntz and Catharina and Mage. Verdruss, and d. young.

- Jacob, b. on Mar. 25, 1769, bapt. at Maytown Lutheran Church on Mar. 30, 1769, and spon. by Jacob and Elizabeth Kinter. He m. Anna Maria, dau. of Jacob Pflieger, on Apr. 13, 1797, and d. in York Township on June 3, 1854. He was Director of the Poor in York Township from 1826 to 1829. He purchased lots in Freystown with his bro. Nicholas. He inherited the mill property and adjoining land from his father.

- Elizabeth, b. on Nov. 26, 1771, m. Henry, son of Philip Jacob and Maria Catherina (Ziegler) King, and d. in York Co. in Dec. 1812.

 George, b. on Feb. 3, 1774, bapt. at Christ's Lutheran Church of York on May 8, 1774, and d. young.

Catherine, b. on June 26, 1776, bapt. at Christ's Lutheran Church of York on Sept. 1, 1776, m. John Brillinger, and d. on Jan. 24, 1846. He was b. on Feb. 5, 1772, and d. on Apr. 5, 1820. They had 50 acres in Spring Garden Township, a mill property consisting of 160 acres in Manchester Township, 400 acres in Windsor Township, 50 acres in Hellam Township, and 2 lots in New Holland. He was one of the original directors of the York National Bank.

 Daniel, b. on June 11, 1779, bapt. at Christ's Lutheran Church of York on Aug. 8, 1779, m. Barbara, dau. of Jacob and Barbara

(Kohr) Stoehr, and d. on Mar. 10, 1824. She was b. on Feb. 1, 1786, and d. on Feb. 2, 1871. He inherited 44 acres and 77 perches from his father, which he sold to purchase land in Newberry Township (200 acres) and Conewaygo/Newberry

Township (115 acres and a mill).

- Johan Georg, b. about 1732. He m. Christina, dau. of Heinrich and Susanna (Miller) Spengler (see entry), on May 30, 1758, and Maria Magdalena Kohler. Christina d. in York Co. about 1782/83. While in York Co., he resided in Dover Township, and his children were bapt. at Strayer's. He was naturalized on Apr. 1, 1765. He served in the Revolutionary War as a Private in Captain Godfrey Frey's Company, 3rd Battalion. He moved to Botetourt Co., VA, in the fall of 1787. He had the following children:

Susanna, b. about 1759, m. Carl, son of Philip Casper and Margaretta Salome Spengler (see entry), and d. in Botetourt Co. about 1803/4. He was b. in 1746, and d. on Sept. 16, 1833. Charles was a Private in Captain Philip Albright's Company, and later an Ensign in the 4th Company, 1st Battalion, during the Revolutionary War. On Apr. 9, 1790 he purchased 150 acres on the North Side of the James River in Botetourt Co. He was a blacksmith.

Johan Adam, b. on Jan. 28, 1763, and d. about 1783.

Eva Margaretha, b. on June 28, 1765, bapt. on Aug. 18, 1765, spon. by Michael and Eva Margaretha Ebert, and d. about 1783.

- Nicholas, b. about 1768, and d. about 1810.

Johan Georg, b. on Nov. 17, 1770, bapt. on May 13, 1770, spon. by George, Susanna and Henrich Spengler, and d. about 1783.

- Magdalena, b. on Feb. 23, 1774, bapt. at Christ's Lutheran Church of York on Apr. 3, 1774, and m. John Hinderleiter, and d. in Botetourt Co., VA. He was b. in Berks Co., PA, and d. in Botetourt Co. in 1844. He had land on Catawba Creek.

 Peter, b. on Oct. 12, 1776, bapt. at Christ's Lutheran Church of York on Dec. 25, 1776, and m. Catherine, and d. in Botetourt Co. in Feb. 1827. She d. about Sept. 1843. He inherited land on Looney's Mill Creek (purchased by his father in 1791) from his

father

Johan Adam, b. in Apr. 1734. He m. Maria Magdalena, dau. of Paul and Anna Eva (Schwab) Burkhart (see entry in Manchester section), on June 17, 1760. She was b. on Oct. 13, 1740. Adam was residing in York Co. in 1796. He worked in his father's mill with his bros. Peter and Nicholas after his father's death. He was naturalized on Aug. 23, 1764. He was an elder of Strayer's Church in 1767, and Supervisor of the Highways in 1775. He served in the York County Militia under Captain Adam Schaffer's Company, and Captain Christian Coffman's Company from 1777-79. He resided in

Dover Township, and purchased 80 acres on Feb. 19, 1773. He probably went to live with one of his children, and it is uncertain which Township he d. in. Adam and Maria Magdalena had the following children:
