Children of Cornelius Wiltsee and their Families

This generation spelled the name Wiltsee and following generation dropped one "e", and then next generation added an "i" making it Wiltsie, and several of the clan still spell it that way.

In Cornelius' will he spelled one of his sons Martin in one place and in another Martyn. Martin or Martyn's widow remarried after his death to a Timothy Langdon.

Jeremiah was in the mercantile business for a number of years. He lived in Vermont a few years but owing to molestation by outlaws moved to Bennington, Vt., and remained there a few years. He then moved to Hillsdale, Vt., and from there moved to Bethlehem, N.Y., near Albany, near the close of the revolution, and died several years later at Bethlehem, N.Y.

Thomas Wiltsee, son of Jeremiah, married Elizabeth Carey who died 3 Aug. 1814, and in the fall of 1768 he and his brother Jeremiah moved to Hopewell, Duches Co., N.Y., then to Pownell, Vt., and on 22 June 1815 Thomas Wiltsee giving the name of J. Thomas Wiltsee married the widow Eunice Brown, the letter J. introduced before the first name Thomas is to show he was the son of Jeremiah. Thomas Wiltsee died 6 Nov. 1826 in his 82nd year.

In the family Bible formerly owned by Thomas Wiltsee, published in 1785, there is a record of the birth of Thomas Wiltsee, born 9 Oct. 1745 and Elizabeth Carey Wiltsee born 15 Aug. 1750, and of their marriage on 18 April 1769 and of dates of births of their fourteen children. The sixth Jeremiah was born 15 Nov. 1780 and died 15 Dec. 1781, age 13 months. The next child was born near Pownell, Vt. on 29 Aug. 1782. He was named Jeremiah after his deceased brother. In this Bible the surnames of all the children were spelled Wiltsee except the last two and theirs was spelled Wiltse.

There were no children from the marriage of Thomas and Eunice Brown Wiltsee. Thomas was a successful business man.
