Exean "Eva Ann" Atkison Goodwin was born on 24 Jul 1850 in Vinton County, Ohio, USA as the fourth child of Joseph Atkison Sr. and Harriet Janes. She had five siblings, namely: Thomas, Nancy M, Margaret, Samuel, and Joseph Henry.

Exean was only about 6 years old when her father Joseph died and she was mentioned in the Probated Will.

She was age 10 when her uncle, Henry James, Harriet's brother was appointed Guardian of all the children.

In 1860 Census, Exean "Eva Ann" Atkison lived in Union Twp, Morgan Co. Ohio. Apparently living next door to Harriet's brother Henry. Four children are listed. Harriet is now age 43. The children are Thomas age 14, Nancy age 13, **Eva A age 10**, Joseph age 3 (NOTE)Margaert and Samuel iare not in Household. Found them living in household of Elisabeth Thomson.

When Exean was ninteen, she married Joseph Glover Goodwin,son of Nathan L Goodwin and Diantha Hull, on 03 Apr 1870 in Hocking County, Ohio.



Joseph and Exean "Eva Ann" Atkison Goodwin had 5 children:

Theodore Franklin Goodwin was born on 14 Oct 1870 in Union Furnace, Hocking, Ohio, USA. He died on 20 Sep 1922 in Paulding, Paulding, Ohio. He married Elizabeth Belle "Ella" Bergman Goodwin on 16 Jan 1892 in Paulding County, Ohio. He died in 1920.

Joseph Henry Goodwin was born on 02 Nov 1872 in Paulding County, Ohio. He died on 07 May 1938 in Scott, Paulding, Ohio.

Loretta Rozella "Etta, Nettie" Goodwin Dally was born on 13 Jan 1877 in Paulding County, Ohio. Died on 17 Feb 1931 in Blue Creek, Paulding, Ohio. She married Russel B. Young on 11 Mar 1897 in Scott, Paulding, Ohio. She married Carl F Dally on 29 Jun 1903 in Scott, Paulding, Ohio.

Lucius Hershell Goodwin was born on 17 Mar 1879 in Ross County, Ohio. He died on 12 Sep 1959 in Toledo, Lucas, Ohio. He married Bernice L. (unknown) Goodwin about 1912.

Albert Edward Goodwin was born on 14 May 1881 in Ross, Butler, Ohio. He died 16 Dec 1967 in Paulding, Paulding, Ohio. He married Mary Florence Morris Goodwin on 15 Oct 1904 in Scott, Paulding, Ohio.

The Charles Goodwin Family were living in Grover Hill, Paulding, Ohio in 1900. Joseph 49 and Exean 49. The children were Joseph H 29, Etta R 23, and Lucius H 21.

Exean, now a widow and 59 years old as of the 1910 Census, is still living in the Grover Hill area. Her son, Joseph Henry at age 38 is living with her.

Ten Years later in the 1920 Census, of Latty Twp. Paulding County, Exean is now 69 and her son, Joseph Henry is 47.

Exean at age 90, and her son Joseph Henry age 57, are still living, per the 1930 Census, in Latty Twp. Paulding County, Ohio.

Exean Atkison Goodwin died March 4 1935 while living in Latty, Paulding County, Ohio. She is buried in Middle Creek Cemetery in Washington, Paulding, Ohio. She was also known as Eva Ann.

The Goodwin Family

Joseph Glover Goodwin was born on the 14th of July 1847 in Vinton County, Ohio. His parents were Nathan L and Diantha Hull Goodwin.

In the 1850 Census, Starr, Hocking, Ohio, Joseph is 4 years old. His father, Nathaniel age 50, Dremtha(Diantha) age 44, Henry age 20, Simon age 18, Salmaon (Solomon) age 15, Nathan (jr?) age 13, David age 8, Almon (Almond) age 6 and the baby Mary has no age listed.

On the 1860 Census, of Starr, Hocking, Ohio, Joseph is now age 13, Nathaniel age 60, Diantha age 56, Henry age 30, David age 18, Almond age 15 and Mary is now age 10.

Joseph Grover Goodwin and Exean Atkison were married on April 3 1870, in Waydenville Post Office, Starr Twp, Hocking County Ohio. Pg 35 ln 17.
