According to NC deed recordings Joseph and his wife Caty were buying and selling land in Orange Co., NC for a number of years beginning 11 Jan 1771 and ending in the late 1790's.[1] Joseph - like his older brother John - may have been part of a group called Regulators who were resisting the corruption and unfair taxation practices of then-Governor Tryon's administration. Joseph served the cause for independence in the American Revolution as is evidenced by a pay voucher issued to him 28 Feb 1782.[2] Many veterans were awarded bounties of land by the US government as reward for their military service. Families of this group first stared coming to the Grainger Co., TN area about 1791/92. Joseph and his family settled along the north side of the Holston River two miles below the mouth of German Creek.

"Some of the surnames found as neighbors to the Noes and as witnesses to their land records in NC such as Spoon, Rich, Holt and Counts (Coontz) are also linked to the Noes in TN through marriages. These families may have gone to TN together. Some of these same names are found in the early records of VA as well and could be proof of a link with the Noes of early Virginia."[3]

Joseph's first recorded appearance in Grainger Co., TN seems to be a deed dated 15 feb 1798 in which James Nichols sold Joseph Noe 210 acres for \$1,000 [4] Peter Noe - not to be confused with the Peter Noe of Orange, NC - was one of the witnesses to the deed. Again on 20 Feb 1799 Joseph bought 100 acres from David Shelton for \$100.[5] This made up the 310 acres that he was being taxed for on the 1799 tax list of Grainger County.[6]

Joseph was a licensed distiller in Grainger Co., TN and, as such, paid his Federal Distillery Tax (aka "Whiskey Tax") [7]

Joseph Noe and Caty continued to buy, sell and otherwise dispose of property in Grainger Co., TN through 17 May 1810. [8] All deeds were signed by Joseph Noe's mark as he could not write his name.

"Joseph was shown on the 1810 census of Grainger Co., TN as being over 45 years of age with wife of the same age group, one male and one female between 10/16 years old. He apparently was deceased by the 1830 census (there is no 1820 census available for Grainger Co., TN) and no doubt it was his widow who was listed as the 80/90 year old female living with son David in 1830."

He passed away before 1830.
