Jacob Goodpasture is first mentioned Dec. 13, 1753, when Thomas Lewis, the first surveyor of Augusta Co. Virgina, surveyed for him a tract of 90 acres of land on the North branch of Lewis Creek, in BrooksGap, now in Rockbridge Co. Virginia. On the face of the plat is the endorsement: Jacob Goodpasture, transferred to John 90 acres.

Jacob Goodpasture died in 1766, and Daniel Pierce qualified as his administrator. The courtappointed appointed appraisers Jan. 7, 1766. The estate was settled Aug. 22, 1768.On Nov. 19, 1766, it was ordered that Abraham Goodpasture , orphan son of Jacob Goodpasture , be bound to Daniel Pierce to learn the trade of carpenter.

Abraham would have been about 15 or 16 years old at the time.

Abraham Goodpasture must have learned his trade through. He must have not been left penniless, for he was able to marry into one of the first families of Washington Co. Virginia and to take important contracts requiring considerable capital.

At the completion of his apprenticeship he moved to the Southwestern frontier. Here he met and married Martha Hamilton, the daughter of Arthur Hamilton and a niece of Mrs. David Campbell, whose family connection was most powerful.

From Smyth County VA History, pg. 123:

John Campbell sold his farm to Abraham Goodpasture in 1789, and June 18, 1796, Abraham and Martha, his wife, conveyed two acres and thirty-five poles of land on which the meeting house, Royal Oaks Presbyterian Church, was standing to Edward Crow and Samuel McReynolds, trustrees of the Upper Holston Congregation.

Abraham Goodpasture sold his Muddy Creek farm to David Stuart for \$1300 cash on May 31, 1800 and he and his family, except his daughter Margaret, moved across the Indian Reservation, called the Wilderness and settled in that part of Smith Co. that is now included in Overton Co. TN. Margaret had married Andrew McClain of Knox Co. and lived near Bald Camp.

The section of the country to which they went was new and uninhabited. Abraham Goodpasture found a location on Flat Creek, where his youngest son was born, May 13, 1801, three months after President Jefferson's inauguration. Abraham lived in his new home the remainder of his life and is to have died about 1820 at the approximate age of 68 years. His wife Martha Hamilton of course came with him to Overton Co. TN , but I do not knowhow long she survived.
